- The question papers shall be both in English & Hindi. The candidates have the option to write the answer either in English or Hindi.
- The Concerned Cadre Controlling Authority shall conduct the typing test and its result will be declared as per the Recruitment Rules. Typing Test Answer Sheets will be with CCA, who will also get it evaluated at their end. The Answer Sheets will not be sent to NACEN. A Copy of the result shall be sent to NACEN for records.
- Requisition for the question papers must reach to the Assistant Director (Exam) NACEN, Fardabad by 06.11.2016. Any demand for question papers after this period may not be entertained. All question papers will be dispatched either by speed post or, if so requested, will be delivered to any special messenger sent and authorized by the Cadre Controlling Authority.
- The name, address & telephone / fax Nos of Addl/Joint/Deputy/Assistant Commissioner who would be responsible to conduct the examination / to whom question papers are to be sent should also be furnished while sending requisition for the question papers.
- The examination notice is also being posted on NACEN website. The marks obtained in the examination shall also be displayed on NACEN's website www.nacen.gov.in.
- Eligibility of the candidates shall be decided by the Cadre Controlling Authority.

- 9. As per latest amendment in Recruitment Rules, the eligibility is 12th pass or equivalent from any recognized Board/University. Any reference on the question of eligibility shall be for the purpose only entertained by NACEN, which is responsible only to facilitate the conduct of the examination.
- 10. To maintain uniformity within a Commissionerate, result of the examination shall be decided by the Cadre Controlling Authority or by an Authority duly empowered by CCA to do so.
- 11. NACEN, Faridabad reserves the right to cancel the whole examination or the examination of a candidate or that of a Centre or of a cluster of centre if it is convinced that unfair means were used or allowed to be taken or any partiality or injustice is done to anybody in the examination. In similar circumstances, the Invigilator and the Supervisory officers have the right to cancel the examination of a candidate or the whole of Centre under his jurisdiction.
- 12. 'Instruction for Examination' is enclosed as an integral part of this Examination Notice.

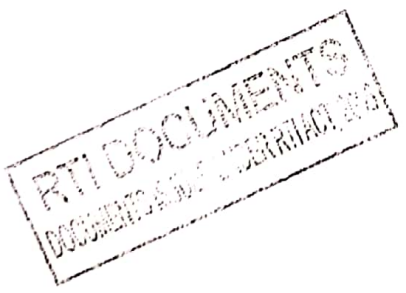

OFFICE MEMORANDUM

Subject: Reservation in promotion – Prescription of lower qualifying Marks/lesser standard of evaluation.

The undersigned is directed to refer to Department of Personnel & Training's O.M.No.36012/23/96-Estt.(Res) dated 22nd July, 1997 vide which various instructions of the Government providing for lower qualifying marks/lesser standards of evaluation in matters of promotion for candidates belonging to the Scheduled Castes and Scheduled Tribes had been withdrawn, on the basis of the Supreme Court's judgement in the case of S. Vinod Kumar Vs. Union of India.

2. The undersigned is further directed to say that the matter has been reviewed, consequent to which the following proviso to Article 335 has been incorporated in the Constitution by the Constitution (Eighty-Second Amendment) Act, 2000:

"Provided that nothing in this Article shall prevent in making of any provision in favour of the members of the Scheduled Castes and Scheduled Tribes for relaxation in qualifying marks in any examination or lowering the standards of evaluation, for reservation in matters of promotion to any class or classes of services or posts in connection with the affairs of the Union or of a State."

3. In pursuance of the enabling proviso of Article 335 of the Constitution, it has now been decided to restore, with immediate effect, the relaxations/concessions in matters of promotion for candidates belonging to SCs/STs by way of lower qualifying marks, lesser standards of evaluation that existed prior to 22.7.1997 and as contained in the instructions issued by the Department of Personnel and Training from time to time including OM No.2/12/69-Estt.(SCT) dated 23.12.1970, No.36021/10/76-Estt.(SCT) dated 21.1.1977 and para 6.3.2 of the DPC guidelines contained in Department of Personnel and Training's O.M. No.22011/5/86-Estt.(D) dated 10.4.1989. In other words, the effect of these instructions would be that the Department of Personnel and Training's OM No.36012/23/96-Estt.(Res) dated 22nd July, 1997 becomes inoperative from the date of issue of this OM.

4. These orders shall take effect in respect of selections to be made on or after the date of issue of this OM and selections finalised earlier shall not be disturbed.

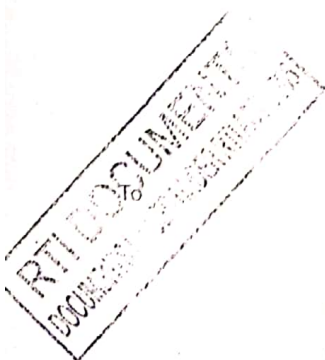

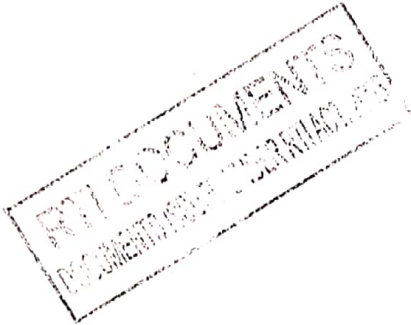

Subject: Departmental examinations for promotion of ministerial officers to the Higher grade to be held in the month of Aug'04 and Sept '04-----Clarifications regarding eligibility, relaxation to SC/ST candidates etc

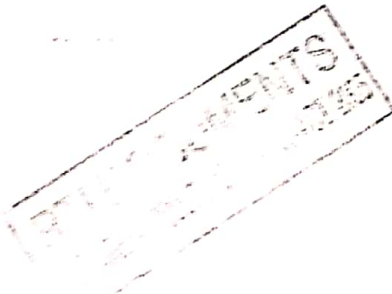
Madam/Sir,

Board has received a reference from Central Excise, Cochin for clarification on following points:

- i) Qualifying service for appearing in departmental examinations for different cadres i.e LDC, Tax Assistant, Senior Tax Assistant, Steno
- ii) Whether any relaxation in qualifying marks can be granted to SC/ST candidates
- iii) Whether an officer is required to appear for the same paper again in departmental promotion exams for different cadres if qualifying marks required and obtained is less in the lower cadre and required more in higher grade in same paper.
- iv) Before cadre restructuring two advance increments were admissible to those LDCs who pass the promotion exam to post of LDC in first attempt. After cadre restructuring which cadre is eligible for advance increment.

2. The issues have been examined in Board and the following is clarified for information and guidance of all cadre-controlling authorities.

- a) The eligibility criteria for promotion to higher grades have already been made clear in new recruitment rules of all the cadres under Column 12. Hence, cadre-controlling authorities may decide the issue in consultation with concerned Chief




Commissioners taking into consideration the provisions in the new recruitment rules.

- b) The relaxation for SC/ST candidates can be granted as per Ministry's instructions F.No A.34011/1/87-Ad III A dated 23.11.1987. In cases, where the qualifying marks are below or more than 40 or 50 out of 100, the relaxation may be granted as per the ratio of qualifying marks given in above-mentioned instructions in all the departmental examinations.
- c) If a ministerial officer who has passed the paper in lower grade with the qualifying marks equal to the qualifying marks in the same paper for higher grade, he may be exempted from appearing in the paper again for departmental examination for promotion to higher grade. However, if he has passed the paper but secured less than the qualifying marks required for higher grade, he has to appear and pass the same paper again in order to show improvement in his performance and knowledge. The working capacity and knowledge of rules/acts varies for carrying out the work in different cadres.
- d) Some references have also been received regarding advance increments. The matter has already been examined and instructions issued vide F.No A.34011/5/04-Ad III A dated 20.7.2004. Hence, no advance increment may be allowed to those officers who have passed the departmental examination either for LDC or Tax Assistant after cadre restructuring.

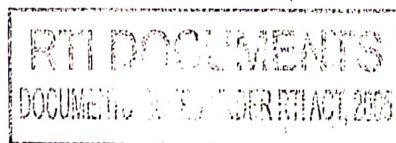

सा.का.नि. 146.—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और केन्द्रीय उत्पाद शुल्क और सीमा शुल्क विभाग, अवर श्रेणी लिपिक, भर्ती नियम, 2002 को उन बातों के सिवाय अधिकृत करते हुए जिन्हें ऐसे अधिक्रमण, 2002 से पहले किया गया है या करने का लोप किया गया है, वित्त मंत्रालय, केन्द्रीय उत्पाद शुल्क, और सीमा शुल्क, अवर श्रेणी लिपिक (समूह 'ग' अनुसूचिवीय) पद पर भर्ती की पद्धति का विनियमन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :—

1. संक्षिप्त नाम और प्रारंभ.—(1) इन नियमों का संक्षिप्त नाम वित्त मंत्रालय, राजस्व विभाग, केन्द्रीय उत्पाद शुल्क और सीमा शुल्क (अवर श्रेणी लिपिक) भर्ती नियम, 2013 है ।

(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे ।

2. पद संख्या, वर्गीकरण और वेतन बैंड तथा ग्रेड वेतन या वेतनमान.—उक्त पद संख्या, उसका वर्गीकरण और उनके वेतन बैंड तथा ग्रेड वेतन या वेतनमान वह होगा, जो इन नियमों से उपाबद्ध अनुसूची के स्तंभ (2) से स्तंभ (4) में विनिर्दिष्ट हैं ।

3. विशेष उपबंध :

(1) जब तक कि केन्द्रीय प्रत्यक्ष कर और सीमा शुल्क बोर्ड द्वारा अन्यथा उपबंधित न हो प्रत्येक प्रमण्डल का पृथक कांडर होगा ।

(2) उप-नियम (1) में किसी बात के होते हुए भी, संबंधित प्रमण्डल के मुख्य उत्पाद शुल्क आयुक्त या मुख्य सीमा शुल्क आयुक्त यदि वह लोकहित में ऐसा करना आवश्यक या समीचीन समझे और ऐसे शर्तों के अधीन रहते हुए जो वह मामले की परिस्थितियों को ध्यान में रखते हुए विनिर्दिष्ट करे और लेखबद्ध किए जाने के कारणों से प्रमण्डल या विभाग में किसी पद को, उसी या सदृश पदों को धारण करने वाले व्यक्तियों के स्थानांतरण द्वारा भरे जाने के लिए, जो यथार्थतः अन्य प्रमण्डल या विभाग या केन्द्रीय उत्पाद शुल्क और सीमा शुल्क बोर्ड के अधीन किसी कार्यालय में कांडर को हों, आदेश द्वारा विहित कर सकेगा ।

4. भर्ती की पद्धति, आयु-सीमा और अर्हताएं, आदि.—उक्त पद पर भर्ती की पद्धति, आयु-सीमा, अर्हताएं और उससे संबंधित अन्य बातें वे होंगी जो उक्त अनुसूची के स्तंभ (5) से स्तंभ (13) में विनिर्दिष्ट हैं ।

5. निरर्हता.—वह व्यक्ति,—

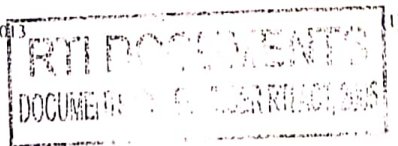
- (क) जिसने ऐसे व्यक्ति से जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है, या
- (ख) जिसने अपने पति या अपनी पत्नी के जीवित रहते हुए किसी व्यक्ति से विवाह किया है,

उक्त पद पर नियुक्ति का पात्र नहीं होगा :

परन्तु यदि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह ऐसे व्यक्ति और विवाह के अन्य पक्षकार को लागू स्वीय विधि के अधीन अनुज्ञेय है और ऐसा करने के लिए अन्य आधार हैं तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकेगी ।

6. शिथिल करने की शक्ति.—जहां केन्द्रीय सरकार की यह राय है कि ऐसा करना आवश्यक या समीचीन है, वहां वह उसके लिए जो कारण हैं उन्हें लेखबद्ध करके, इन नियमों के किसी उपबंध को किसी वर्ग या वर्ग के व्यक्तियों की बाबत, आदेश द्वारा शिथिल कर सकेगी ।

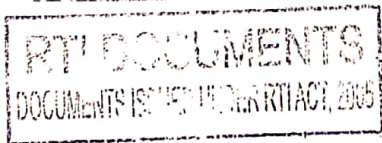

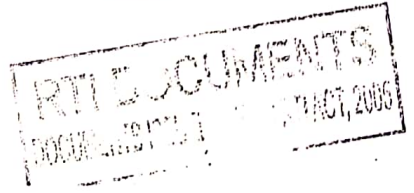

G.S.R. 146.—In exercise of the powers conferred by the proviso to article 116 of the Constitution in relation to superintendence of the Central Excise and Customs Department, Lower Division Clerk Recruitment Rules 1955 in respect of things done or omitted to be done before such superintention, the President hereby makes the following rules regulating the method of recruitment to the post of Lower Division Clerk (Group 'C' Minimum) in the Ministry of Finance, Central Excise and Customs, namely:—

1. Short title and Commencement.—(1) These rules may be called the Ministry of Finance, Department of Revenue, Central Excise and Customs (Lower Division Clerk) Recruitment Rules, 1955.
(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and pay band, grade pay or pay scale.—The number of the post, its classification and the pay band, grade pay or pay scale attached thereto, shall be as specified in columns (2) to (6) of the Schedule annexed to these rules.

3. Special Provision:

- (1) Each Commissionerate shall have a separate cadre unless otherwise provided by the Central Board of Excise and Customs.
- (2) Notwithstanding anything contained in sub-rule (1), the Chief Commissioner of Central Excise or Chief Commissioner of Customs having jurisdiction over the concerned Commissionerate may, if in his opinion it is necessary or expedient in the public interest so to do and subject to such conditions as he may specify having regard to the circumstances of the case and for the reasons to be recorded in writing, order any post in the Commissionerate to be filled by absorption of persons holding the same or analogous post but belonging to the cadre of another Commissionerate or any other office under the Central Board of Excise and Customs, as the case may be.

4. Method of recruitment, age-limit, and qualifications, etc.—The method of recruitment to the post, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (12) of the said Schedule.

5. Disqualification.—No person,—

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the other Backward Classes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in that regard.

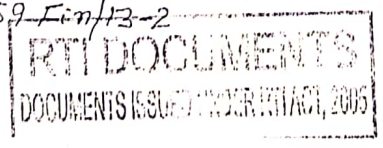

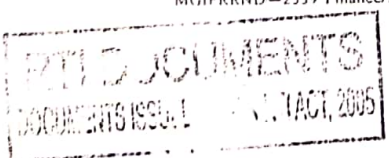

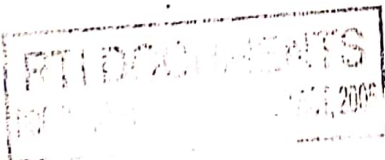
