In compliance of the Order dated 08th Nov. 2024 passed by the Hon'ble CAT, Jaipur Bench, Jaipur in Original Application No. 675/2024 filed by Shri Shekhar Sharma and Others, and consequent upon approval granted by the Central Board of Indirect Taxes and Customs, New Delhi vide letter F.No. A-23011/44/2020-Ad.IIA (Pt.2) dated 07th March 2025, the following officers, who are applicants in the aforesaid OA, are hereby granted Non-Functional Upgradation to grade pay of Rs. 5400/- in PB-2 (revised as Level-9 in Pay Matrix Rs. 53100-167800) after completion of 4 years of regular service in pre-revised grade pay of Rs. 4800/- in PB-2 (revised as Level-8 in Pay Matrix Rs. 47600-151100). 2.
