The information in respect of RTI Application bearing Registration No. GSTJP/R/E/23/00102/1 dated 20.05.2023 filed by you, in respect of Office of the Chief Commissioner of CGST & CX, Jaipur Zone is as under –

Para 1 and 2. *AIO system as on date, not showing any details in regard to Shri Rajesh Pipada GSTIN 08ABMPP7530P1ZU Proprietor KALPANA ENTERPRISES. Therefore, information sought cannot be provided.*

In this regard Hon'ble CIC in the case of Sh. Ashok Kumar Sharma vs B.H.E.L. dated 25 July, 2008 and in various cases has held that information which is not readily available or maintained, cannot be furnished.

Also, you have asked personal information in para 1 of the RTI application and have not shown larger public interest. As per section 8(1)(j) of RTI Act 2005 - information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information. Therefore, information sought cannot be provided as the same falls u/s 8(1)(j) of RTI Act 2005 and further there seems no larger public interest.

Para 3. *RTI application has already been forwarded for para 3 to CPIO, CGST Commissionerate, Udaipur by the Nodal Officer on 23.05.2023.*
