All newly recruited Tax Assistants mentioned at S.No. 1 to 17 in aforesaid Table are hereby relieved in the afternoon of today i.e. 25.10.2021 with direction to join in the respective Commissionerates mentioned against their names. They will not be entitled for any TTA and Joining Time since this allocation is being made on their new recruitment.

3. All the remaining existing Tax Assistants must be relieved by the respective Commissioner/ controlling officer, immediately and should join their new place of posting on or before 05.11.2021.


4. Since the transfer of officer mentioned at S.No. 25 has been made on his own request, he shall not be entitled for any TTA or Joining Time.

5. A consolidated report regarding relieving/ joining of all the above officers, should reach this office by 08.11.2021 from all the Commissionerates.

6. It is further directed that Orders indicating specific charge/ postings within the Commissionerates, should be issued by the respective Commissioners by 05.11.2021 positively. While issuing orders for specific charge/ postings to existing Tax Assistants, the Transfer Policy Guidelines, 2018, as amended, and the History of Postings of the officers should be kept in mind, so as to ensure proper rotation - sensitive & non-sensitive norms etc. as prescribed by the instructions issued by CVC/ CVO. In case of any deviation from the Transfer/ Placement Guidelines, prior approval of the Chief Commissioner should be taken by the respective Commissioners.

7. The Commissioners should ensure that before relieving the existing officers, they hand over their charge under proper Handing Over/ Taking Over note. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officers should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-(Trg-Ref) dated 26.09.2014.
