**CORRIGENDUM**


That in pursuance of interim Order dated 27.08.2010 of **Hon'ble Calcutta High Court** in W.P CT No. 261 of 2018 filed by Shri Samiran Roy & Ors. Vs Union of India & Ors., the Government of India Ministry of Finance Department of Revenue, New Delhi vide letter F.No C-18012/6/2009-Ad. IIB dated 16.09.2010 had directed that *"All the Cadre Controlling Authorities under CBEC are, therefore, requested to complete the process of promotion (to the grade of Superintendent) and make these effective from 30.09.2010."*

2. That, a DPC for regular promotion to the grade of Superintendent Group 'B' was held on 29.9.2010 and the Inspectors who were working as Superintendents on adhoc basis and selected for regular promotion to the grade of Superintendent Group 'B' by the said DPC held on **29.09.2010**, were granted regular promotion to the grade of Superintendent Group 'B' w.e.f 30.09.2010 vide this office Establishment Order No. 74/2010 dated **30.09.2010** in terms of Ministry's aforesaid letter F.No C-18012/6/2009-Ad. IIB dated 16.09.2010.

3. That subsequently, in pursuance of Ministry's letters F.No. A-29014/4/2011-Ad.II.B dated 24.10.2011 and F.No. A-29014/4/2011-Ad.IIB dated 16.02.2012, a Review DPC was held on 27.02.2012 in respect of DPCs held on 12.09.2005, 03.05.2006, 06.07.2006, 22.03.2007, 10.10.2007, 24.04.2008, 30.12.2008, 24.02.2010, **29.09.2010** and 27.06.2011 for regular promotion to the grade of Superintendent Group 'B'. The officers selected by the said Review DPC held on 27.02.2012, were granted regular promotion to the grade of Superintendent Group 'B' vide Establishment Order No. 32/2012 dated 28.02.2012.

4. That now, it has come into the notice that the officers who were required to be promoted to the grade of Superintendent Group 'B' w.e.f 30.09.2010 in terms of the Ministry's aforesaid letter F.No C-18012/6/2009-Ad. IIB dated 16.09.2010, have been granted regular promotion to the grade of Superintendent Group 'B' w.e.f 29.09.2010 instead of 30.09.2010 vide aforesaid Establishment Order No. 32/2012 dated 28.02.2012 due to oversight of the direction given by the Ministry vide aforesaid letter dated 16.09.2010.

5. In view of the above, the date of granting regular promotion to the grade of Superintendent Group 'B' in respect of following officers, is hereby rectified as



30.09.2010 instead of 29.09.2010 in terms of Ministry's aforesaid letter F.No C-18012/6/2009-Ad. IIB dated 16.09.2010 which was issued in pursuance of interim Order dated 27.08.2010 of Hon'ble High Court Calcutta, modifying the aforesaid Establishment Order No. 32/2012 dated 28.02.2012.


