2. In the above referred Tender No. 01/2024, following corrigendum is issued.

2nd paragraph before para 2 at page No. 01 of the Tender Notice –

“The said rented office accommodation of GST APPELLATE TRIBUNAL, JODHPUR is to be taken as a whole unit and not separate or segregated. Only those owners/builders etc. shall apply who have total space of 20000 Square feet approx. (carpet area) available in the single well-maintained building and **single owner in Jodhpur** and not separate buildings at different locations. The entire space of 20000 Square feet approx. is to be made available in the same building and with **single owner as the legal owner**. The Critical Date Sheet is mentioned below.”


