

While issuing orders for specific charge/ postings, the Transfer Policy Guidelines, 2018, as amended, and the History of Postings of the officers should be kept in mind, so as to ensure proper rotation – sensitive & non-sensitive norms etc. as prescribed by the instructions issued by CVC/ CVO. In case of any deviation from the Transfer/ Placement Guidelines, prior approval of the Chief Commissioner should be taken by the respective Commissioners.

6. The Commissioners should ensure that before relieving the officers, they hand over their charge under proper Handing Over/ Taking Over note.
