Consequent upon the recommendations of the DPC Meeting held on 24.10.2019 for promotion to the grade of Lower Division Clerk (LDC) Group "C", the following officers in the grade of Havaldar of GST, Central Excise & Customs, Jaipur Zone, Jaipur are hereby promoted to the grade of Lower Division Clerk Group 'C', in level-2 in Pay Matrix Rs. 19900-63200 plus other allowances, as admissible, on regular basis, with effect from the date they assume the charge of the promoted post i.e. Lower Division Clerk Group "C", at the place of posting detailed in Col.4 of Para 2 below: -

Consequent upon the said promotion, the above mentioned officers may exercise option for fixation of their pay under FR-22(1) (a) (1), within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay 1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. The above mentioned promoted officers must be relieved immediately by the Principal Commissioner, GST & Central Excise, Jaipur to join at their new place of posting (on promotion) under intimation to the CCO. No representation, whatsoever, shall be entertained before they join at their new place of posting. Further specific postings of these officers will be decided by the concerned Principal Commissioner/Commissioners.

5. The aforesaid promotion is subject to the final outcome of the SLPs filed by Shri D. Raghu & Others against Hon'ble Andhra Pradesh High Court's Order dated 02.03.2005 in Writ Petition No.7963/2004.

6. The aforesaid promotion is also subject to the final outcome of the review DPC, if held for promotion to the grade of Inspector with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.) dated 12.05.2016. The Hon'ble CAT, Jaipur Bench, Jaipur granted the stay on the said letter dated 12.05.2016 vide Order dated 03.06.2016 in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others before the Hon'ble CAT, Jaipur Bench, Jaipur against the said letter dated 12.05.2016.

7. The aforesaid promotion is also granted subject to the final outcome of the review DPC, if held with reference to the Ministry's letter F.No. A.32022/39/2018-Ad.III.A dated 14.03.2019. The Hon'ble CAT Jaipur Bench, Jaipur granted the stay on the said letter dated 14.03.2019 vide order dated 30.05.2019 in O.A. No. 291/308/2019 filed by Shri Ramawatar Chouhan & Ors.

8. The promotion of the said officers is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

9. The promotions of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.

10. This issues with the approval of the Chief Commissioner, GST & Central Excise, Jaipur Zone, Jaipur.
