

7. The promotion of the said officers are subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

8. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured in above list, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Superintendent, Group 'B' (Gazetted) and this fact should be reported to this office immediately. In case, the officers are clear from the vigilance angle, their joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.
