Consequent upon the recommendations of the DPC Meeting held on 25.01.2022 for promotion to the grade of **Assistant Sub-Inspector (Weapons), Group 'C', Shri Narendra Kumar S/o Sh. Kishan Lal (DOB 28.04.1964)**, Head Havaldar, office of the Deputy/Assistant Commissioner, CGST & CX Div-I, Kota, is hereby promoted to the grade of Assistant Sub-Inspector (Weapons), Group 'C' in Level-3 of Pay Matrix Rs. 21700-69100 plus other allowances, as admissible, on regular basis, with effect from the date of assumption of charge of the promoted post i.e. in the grade of Assistant Sub-Inspector (Weapons), Group 'C'.

Consequent upon the said promotion, the above mentioned officer, if he is already not drawing the pay scale in Level-3 of Pay Matrix Rs. 21700-69100 and above, under the MACP Scheme, may exercise option for fixation of his pay under FR-22(1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1), dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The said officer should submit his joining report on regular promotion to the concerned controlling officer under intimation to this office. He is posted at his present place of posting on the said promotion to the grade of Assistant Sub-Inspector (Weapons), till further orders.

4. The promotion of the said officer is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.


