**ORDER**

Department of Pension & Pensioner's Welfare OM No. 57/05/2021-P&PW(B) dated 03.03.2023 stipulates that in all cases where the Central Government Civil Employee has been appointed against a post or vacancy which was advertised/notified for recruitment/ appointment, prior to the date of notification for National Pension System i.e. 22.12.2003 and is covered under the National Pension System on joining service on or after 01.01.2004, may be given a one-time option to be covered under the Central Civil Services (Pension) Rules, 1972 (now 2021). This option may be exercised by the concerned Government servants latest by 31.08.2023.

2. In pursuance of the aforesaid Office Memorandum, the following officers have exercised their one-time option to be covered under the Central Civil Services (Pension) Rules, 1972 (now 2021):

The representation submitted by the above officers have been considered in light of the instructions of DoP&PW vide their OM No. 57/05/2021-P&PW(B) dated 03.03.2023 and it is found that all the aforementioned officers have been appointed as Inspector, Central Excise consequent upon qualifying SSC Combined Graduate Level Examination, 2003 and 2004 for which notification of the examination was published on 25.01.2003 and 18.10.2003 respectively.

4. The matter regarding coverage of above officers under CCS (Pension) Rules, 1972 based on the option exercised by them was placed before the Appointing Authority for consideration, in accordance with the instructions of DoP&PW OM No. 57/05/2021-P&PW(B) dated 03.03.2023. The Appointing Authority has approved the request of the aforementioned officers for switching over from National Pension System to Old Pension Scheme under CCS (Pension) Rules, 1972 (now 2021).

5. The concerned officers are required to subscribe to the General Provident Fund (GPF) in terms of the provisions contained in Para 8 of the DoP&PW's OM dated 03.03.2023.

6. Concerned Pr. Commissioner/ Commissioner are requested to take note of the above and take necessary steps to settle the account of the corpus in the NPS Account of the aforesaid officers in accordance with para 8 of DoP&PW's OM No. 57/05/2021-P&PW(B) dated 03.03.2023.
