The promotion of the said officers is made on "IN-SITU" basis i.e. such Stenographers Grade-I, Group 'B' (Ministerial Non-Gazetted) shall continue to work at the same place where they are presently posted till their posting orders for Stenographer Grade-I, Group 'B' (Ministerial Non-Gazetted) are issued by the Competent Authority.

3. Consequent upon the said promotion, the above mentioned officers, may exercise option for fixation of their pay under FR-22 (1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the Jarnail Singh batch of cases in the matter of reservation in promotion.
