An Original DPC Meeting was held on 28.12.2023 for promotion to the grade of Superintendent, Group 'B' (Gazetted) for the panel / vacancy year, 2024. The recommendations of the said DPC have been approved by the competent authority. On the basis of recommendations of said DPC, the following Inspector is hereby promoted to the grade of Superintendent, Group 'B' (Gazetted), in Level-8 of Pay Matrix Rs. 47,600/- to Rs.1,51,100/- plus other allowances, as admissible, on regular basis, with effect from the date of assumption of the charge of the promoted post i.e. in the grade of Superintendent, Group 'B' (Gazetted) :-

2. The promotion of the said officer is made on "IN-SITU" basis i.e. such Superintendent, Group 'B' (Gazetted) shall continue to work at the same place where he is presently posted till his posting orders for Superintendent, Group 'B' (Gazetted) is issued by the Competent Authority.

3. Consequent upon the said promotion, the above mentioned officer, may exercise option for fixation of his pay under FR-22 (1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

5. The promotion of the said officer is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

6. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and Order dated 26.09.2022 of Hon'ble CAT, Jaipur Bench, Jaipur in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others.

7. The promotion of the said officer is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

8. The supervisory authority concerned shall ensure that if the officer whose name figures in above list, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Superintendent, Group 'B' (Gazetted) and this fact should be reported to this office immediately. In case, the

officer is clear from the vigilance angle, his joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.

This issues with the approval of the competent authority.




