Consequent upon the recommendations of the Regular DPC Meeting held on 27.09.2022 for the panel / vacancy year 2022 for promotion to the grade of Superintendent, Group "B" (Gazetted), the following officer in the grade of Inspector of GST, Central Excise & Customs (Jaipur Zone), Jaipur is hereby promoted to the grade of Superintendent, Group "B" (Gazetted), in Level-8 of Pay Matrix Rs. 47,600/- to Rs. 1,51,100/- plus other allowances, as admissible, on regular basis, with effect from the date of assumption of the charge of the promoted post i.e. in the grade of Superintendent, Group "B" (Gazetted) :-

2. Consequent upon the said promotion, the above mentioned officer may exercise option for fixation of their pay under FR-22(1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

4. The aforesaid promotion of officer is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

5. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and Order dated 26.09.2022 of Hon'ble CAT, Jaipur Bench, Jaipur in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others.

6. The promotion of the said officer, is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

7. The Commissioner, Audit Commissionerate, Jodhpur and supervisory authority concerned shall ensure that if the aforesaid officer, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Superintendent, Group 'B' and this fact should be reported to his office immediately. In case, he is clear from the vigilance angle, his joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.
