





Sub.: Rajya Sabha Unstarred Question Dy. No. S3845 for on "Delay in cases due to non-filing of Affidavits".

Rajya Sabha Unstarred Question Dy. No. S3845 for 22.12.2022 on "Delay in cases due to non-filing of Affidavits". The question reads as follows-

- (a) whether Government is aware that delays in disposal of matters by the courts are often caused by the Supreme Court and High Court on account of non-filing of affidavit/responses on behalf of Government and its corporations;
 - (b) whether any time has been fixed by Government for filing response from the date of receiving the notices/show cause for filing its response and, if so, its details; and
 - (c) details of the monitoring system, if any, to ensure that responses/affidavits are timely filed on behalf of Government ?
