Consequent upon the said promotion, the above mentioned officer, may exercise option for fixation of his pay under FR-22 (1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. 4. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

5. The promotion of the said officer is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.
