Consequent upon the recommendations of the Regular DPC Meeting held on 30.09.2022 for the panel / vacancy year 2022 for promotion to the grade of Tax Assistant, Group "C", **Shri Padma Ram (ST), Lower Division Clerk** (DOB - 04.03.1972), Appeals Commissionerate, Jodhpur, is hereby promoted to the grade of Tax Assistant, Group "C" in Level-4 of Pay Matrix Rs. 25,500/- to Rs. 81,100/- plus other allowances, as admissible, on regular basis, with effect from the date of assumption of the charge of the promoted post i.e. in the grade of Tax Assistant, Group "C".

2. Consequent upon the said promotion, the above mentioned officer may exercise option for fixation of their pay under FR-22(1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The promotion of the said officer is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

4. The Commissioner, Appeals Commissionerate, Jodhpur and supervisory authority concerned shall ensure that if the officer mentioned above, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Tax Assistant, Group 'C' and this fact should be reported to his office immediately.


