The sale against this enquiry shall be governed by the Terms and Conditions set out in Annexure-"A" to this invitation.



TERMS & CONDITIONS

1. Open auction of the vehicle will be held on 28.09.2020 at 11.00 hrs. Intending bidders will have to be present at the time of auction.
2. The bidders will have to submit a demand draft of Rs. 5000/- drawn in favour of "Commissioner, CGST & Central Excise, Jaipur" before taking part in the open bidding process. The offer shall remain valid for a period of 1 month from the date of receipt of the offer.
3. The rate quoted by the bidder for purchase of old condemned vehicle will be an all inclusive and "AS IS WHERE IS BASIS". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicles on a date and time specified by this office and will arrange the transportation of the same on that day at his expense.
4. The vehicle will be disposed off on the basis of highest rate. However, this office reserve the right to withdraw the vehicles from the bidding process in case the quoted price received is less than the reasonable market price.
5. The successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/time entails the forfeiture of the contract as well as Earnest Money. After delivery of the vehicles, this office will not be responsible for any damages to the vehicle or person.
6. This office reserves the right to annual the bidding process at any time prior to award of contract including rejection of any or all offers after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office's auction.
7. The bidders may visit and physically inspect the cars before taking part in the open auction. **Shri Hari Narayan Meena, Administrative Officer (H)**, Office of the Commissioner, CGST & Central Excise, Jaipur may be contacted for inspection of the vehicles. **The inspection of the vehicles may be done from 10.00 A.M. to 05.00 P.M. of any working day up to 25.09.2020.** No complaint whatsoever will be entertained after closing of bidding process.
8. The vehicle shall be handed over to the successful bidder against 100% deposit of offer/bid value.
9. The payment will be accepted by this office in the form of **Demand Draft of a nationalized bank** only. The payment has to be submitted by the successful bidder within 7 days of the date of delivery of the order otherwise the offer will be cancelled and earnest money shall be forfeited.
10. Disputes, if any, shall be subject to jurisdiction in the court of Jaipur only.
11. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
12. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
13. The scheduled day for holding the open auction, if declared to be holiday due to any unforeseen reasons, the same will be held the next immediate working day.

15. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any of the documents as documentary evidence for proof of their address. (Ration Card/Voters Identity Card/Aadhar Card in case of individual and Registration Certificate in case of firms etc.)
