1. 2. It is further directed that Orders indicating Specific Charge / Posting within divisions, should be issued by the respective Jurisdictional Assistant Commissioners by 17.06.2019 positively after getting prior approval from the head quarter office. While issuing Orders for specific charge / postings, the Transfer Policy guidelines 2018 and the HOP of the officers should be kept in mind, so as to ensure proper rotation of such officers as per instructions issued by CVC/CVO.
3. The officers, who have been given extension at the station or whose request for pre-mature transfer has been considered, should be posted to non-sensitive charge only.
4. The Controlling Officers (Asstt. Commissioners) should ensure that before relieving the officers, they hand over their charge under proper Handing over / Taking Over note. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officers should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-(Trg-Ref) dated 26.09.2014.
5. Since the transfers of officers mentioned at S.No. 01, 07, 10, 12 & 24 have been made on their own request, they shall not be entitled for any TTA or joining time either at the time of joining their new place of posting in AGT 2019 or at the time of their repatriation in the subsequent AGT, as the case may be.
6. All the representations/requests received in the grade of Superintendent stand disposed off, after issuance of this order.
