

No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others before the Hon'ble CAT, Jaipur Bench, Jaipur.

6. The promotion of the said officers is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

7. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.


