
2. In this regard, the requisite reply to part (b), (c) and (d) is as under:

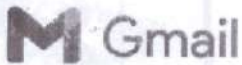
