In pursuance of approval of the Pr. Commissioner, Directorate of Logistics, New Delhi conveyed vide letter issued under F.No. DOL/COMM/POLY/2/2022-COMM-DoL-DELHI dated 03.03.2022, by the Additional Director (Marine/ Communication), DoL, New Delhi, **Shri Joginder Singh Dahiya**, Sr. Technical Assistant, Customs (Prev.) Commissionerate, Jodhpur (Hqrs. at Jaipur) is hereby transferred to the Directorate of Logistics, New Delhi on **“Loan Basis”** for a period of **two (2) years** with effect from the date of his joining in Directorate of Logistics, New Delhi, on the following terms and conditions:-

- (A) While working in the Directorate of Logistics, New Delhi, all kinds of payments to **Shri Joginder Singh Dahiya**, Sr. Technical Assistant, towards his pay and allowances will have to be borne by his parent Commissionerate. His services will also be borne by his parent Commissionerate i.e. he will be on the working strength of his parent Commissionerate. He will not be entitled to any kind of special pay, allowance etc.
 - (B) No TTA and Joining Time will be admissible to him in this event of transfer on ‘Loan Basis’, since this transfer is being allowed on his own request.
 - (C) On this transfer on ‘Loan Basis’, he will not be entitled for promotion, confirmation, seniority etc. in Directorate of Logistics, New Delhi.
 - (D) He is liable to be repatriated to his parent Commissionerate at any time without assigning any reason.
2. On having accepted the above terms and conditions, **Shri Joginder Singh Dahiya**, Sr. Technical Assistant may be relieved immediately to report to the Directorate of Logistics, New Delhi, under intimation to this office.
 3. This issues with the approval of the Chief Commissioner, CGST & CE, Jaipur Zone, Jaipur.
