2. The promotion of the said officers is made on "IN-SITU" basis i.e. such Tax Assistant, Group 'C' shall continue to work at the same place where they are presently posted till their posting orders for Tax Assistant, Group 'C' is issued by the Competent Authority.

3. On promotion, benefit of option for fixation of pay in the promotional post, if admissible, shall be available to the officers named above in terms of provisions contained in the DoPT's O.M. No. DOPT-1667551701810 dated 13th September 2022. They may exercise the option, if benefit of the same is admissible, within one month from the date of their promotion. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. This order is subject to the final outcome of O.A. No. 672/2024 filed by Shri Man Singh and others before Hon'ble CAT Bench, Jaipur.

5. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

6. The promotion of the said officers is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

7. The officers should be allowed to join the promoted post, if clear from the vigilance angle.
