**ESTABLISHMENT ORDER NO. CCU -44/2024**

Whereas, as per recommendations of the Original DPC dated 23.03.2018, **Shri Raj Kumar Pannu, Inspector (D.O.B. - 25.06.1978)** presently posted at CGST & Central Excise Commissionerate, Jodhpur, was promoted to the grade of Superintendent Group 'B' on regular basis in the pay band / scale of Rs. 9300-34800 (PB-2) with corresponding grade pay of Rs. 4800/- (revised as level-8 in Pay Matrix Rs. 47600-151100) for the vacancy year 2018 vide Establishment Order No. 31/2018 dated 27.03.2018. In compliance of the aforesaid Establishment Order, he had joined as Superintendent on 01.04.2018.

2. Whereas, he has been granted the Non-Functional Upgradation to the grade pay of Rs. 5400 in PB-2 (Revised as Level-9 in Pay Matrix Rs. 53100-167800) w.e.f. 01.04.2022 i.e. after completion of 4 years of regular service in the grade of Superintendent, Group 'B' (Gazetted) after regular promotion in the grade pay of Rs. 4800/- (revised as level-8 in Pay Matrix Rs. 47600-151100) vide Establishment Order No. 50/2022 dated 11.07.2022.

3. Whereas, consequent upon the revision of seniority lists of Inspectors as on 31.12.2016 & 31.03.2018 vide letter F.No. GCCO/II/26(1)2022/Admn./841 dated 23.08.2023, a Review DPC was held on 29.08.2023 in respect of earlier DPCs (including Original DPC dated 23.03.2018) for regular promotion to the grade of Superintendent.

4. Whereas, as per the recommendations of the aforesaid Review DPC dated 29.08.2023, the name of Shri Raj Kumar Pannu has been excluded from the select panel prepared by the Original DPC dated 23.03.2018 for the vacancy year 2018 and included in the select panel of Supplementary DPC dated 29.05.2018 (Reviewed on 23.07.2019) for the vacancy year 2018. He has been granted promotion to the grade of Superintendent, Group 'B' (Gazetted) w.e.f. 24.07.2019 vide this office Establishment Order No. CCU-32/2023 dated 01.09.2023.

5. Whereas, since, he has now been promoted to the grade of Superintendent Group 'B' (Gazetted) w.e.f. 24.07.2019 and completed 4 years of regular service in the grade of Superintendent Group 'B' (Gazetted) on 24.07.2023, therefore, **Non-Functional Upgradation to the grade pay of Rs. 5400 in PB-2 (Revised as Level-9 in Pay Matrix Rs. 53100-167800 granted to Shri Raj Kumar Pannu, Superintendent w.e.f. 01.04.2022, vide aforesaid Establishment Order No. 50/2022 dated 11.07.2022, is hereby withdrawn.**

Whereas, in pursuance of Board's letter F.No. A-26017/98/2008-Ad.IIA dated 21.11.2008, 11.02.2009, 16.09.2009 and 23.12.2009 read with Board's letter F.No. A-26017/166/2009-Ad.II.A dated 25.01.2011 and F.No. A-26017/2019-2016-Ad.II A dated 10.04.2017, Shri Raj Kumar Pannu, Superintendent, Group 'B' (Gazetted) who has completed 4 years regular service in the grade of Superintendent, Group 'B' (Gazetted) after regular promotion in the pay scale of Rs. 9300-34800 with the grade pay of Rs. 4800 in PB-2(Revised as Level-8 in Pay Matrix Rs. 47600-151100), is hereby granted the **Non-Functional Upgradation to the grade pay of Rs. 5400 in PB- 2** (Revised as Level-9 in Pay Matrix Rs. 53100-167800) w.e.f. 24.07.2023.
