

In case of any deviation from the Transfer/ Placement Guidelines, prior approval of the Chief Commissioner should be taken by the respective Commissioners.

7. The Commissioners should ensure that before relieving the officers, they hand over their charge under proper Handing Over/ Taking Over note. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officers should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-(Trg-Ref) dated 26.09.2014.
