**विषय:** कर्मचारी चयन आयोग, संयुक्त स्नातक स्तरीय परीक्षा, 2024 के माध्यम से कर सहायक के पद के लिए अभ्यर्थियों का दस्तावेज सत्यापन के स्थान और तिथि की सूचना –संबंधित।

मानव संसाधन विकास महानिदेशालय (डी.जी.एच.आर.डी.), केंद्रीय अप्रत्यक्ष कर एवं सीमा शुल्क बोर्ड (सीबीआईसी), नई दिल्ली ने ईमेल दिनांक 18.03.2025 के माध्यम से कर्मचारी चयन आयोग द्वारा आयोजित संयुक्त स्नातक स्तरीय परीक्षा, 2024 के परिणामों के आधार पर केन्द्रीय वस्तु और सेवाकर अंचल, जयपुर में कर सहायक के पद पर 199 अभ्यर्थियों को दस्तावेज सत्यापन हेतु आवंटित किया है।

The Directorate General of Human Resource Development (DGHRD), Central Board of Indirect Taxes and Customs (CBIC), New Delhi vide email dated 18.03.2025 has assigned 199 candidates for the post of **Tax Assistant** to CGST & Central Excise (Jaipur Zone), Jaipur to conduct their documents verification based on the result of the Combined Graduate Level Examination, 2024 conducted by Staff Selection Commission.

2. इस संबंध में **अनुलग्नक 'ए'** में दर्शाए गए अभ्यर्थियों को निर्देश दिया जाता है कि वे अनुलग्नक 'ए' में उनके नाम के सामने दर्शाये गये स्थान पर निर्धारित दिनांक एवं समय पर दस्तावेज सत्यापन के लिए उपस्थित होना बिना किसी चूक के सुनिश्चित करें। अभ्यर्थियों को सलाह दी जाती है कि वे दस्तावेज सत्यापन में भाग लेने के लिए कम से कम 2 दिनों के लिए अपने यात्रा कार्यक्रम की योजना बनाएं। दस्तावेज सत्यापन की प्रक्रिया जोन के नामित प्राधिकारी द्वारा डोजियर की प्राप्ति और सत्यापन के अध्यक्षीन है।

In this regard, the candidates figuring in **Annexure 'A'** are directed to report for Document Verification at the place mentioned against their names in the Annexure-A on the scheduled date and time without fail. Candidates are advised to plan their itinerary for at least 2 days so as to attend DV. The process of Document Verification is subject to receipt and verification of dossiers by the designated authority in the Zone.

The Attestation Form, **in triplicate**, duly filled in all respects (by hand only), should be produced at the time of document verification to the undersigned without fail.

e) Income and Assets Certificate for EWS Category Candidate (Valid for the financial year 2024-2025 issued on the basis of Income for the financial year 2023-2024).

f) Character Certificate from two different Gazetted officers of the Central or State Government or Stipendiary Magistrate. (3 sets in original for minimum 2 years)

छ) केन्द्र या राज्य सरकार के राजपत्रित अधिकारी या वृत्तिकाग्राही मजिस्ट्रेट से पहचान प्रमाण पत्र (मूल में 3 सेट, कम से कम दो वर्ष के लिये) ।

g) Identity Certificate from a Gazetted officer of the Central or State Government or Stipendiary Magistrate. (3 sets in original for minimum 2 years)

ज) स्वस्थता प्रमाण पत्र सरकारी चिकित्सालय के उस चिकित्सा अधिकारी से प्राप्त किया जाना है जो सिविल सर्जन के पद से नीचे न हो। महिला उम्मीदवारों को प्रमाण पत्र महिला चिकित्सा अधिकारी से प्राप्त किया जाना है जो सिविल सर्जन के पद से नीचे न हो। (अनुलग्नक 'बी')। इस उद्देश्य हेतु उम्मीदवारों को इस नोटिस के साथ संलग्न "Statement and declaration" प्रपत्र में सूचना भरकर चिकित्सा अधिकारी के समक्ष उपस्थित होना है।

h) Certificate of Fitness from a Medical Officer not below the rank of a Civil Surgeon. Female candidates should get the certificate from a female Medical Officer not below the rank of a Civil Surgeon (Annexure 'B'). **For this purpose, the candidate should appear before the medical officer alongwith duly filled in enclosed "Statement and declaration".**

In the event of not reporting on the prescribed date for the Document Verification, it will be presumed that candidate is not interested in accepting the offer of appointment in the department and his nomination will be treated as cancelled.
