ESTABLISHMENT ORDER NO. 68 /2019

In compliance to Hon'ble CAT, Jodhpur Bench, Jodhpur's Order dated 05.09.2011 in O.A. No. 217/1998 and Order dated 12.04.2017 of Hon'ble High Court of Rajasthan in Writ Petition (C) No. 9138/2013 read with Board's letter F.No. C-18012/21/2012-Ad.IIB dated 31.07.2018, Shri O.P. Saharan, is required to be promoted to the Grade of Superintendent, Group 'B' on notional basis w.e.f. 29.08.1997 from the grade of Inspector on the basis of length of service rendered by him in the grade of Inspector (i.e. from the date of his initial appointment to the post of Inspector) in Central Excise and Customs Department. Accordingly, Shri O.P. Saharan is hereby promoted to the grade of Superintendent, Group 'B' on notional basis w.e.f. 29.08.1997.

2. On promotion, his seniority will remain at the bottom of the order issued in respect of other officers who got promotion in the respective phase of upgradation as per the extent of rules, since his service only be counted for the purpose of eligibility in the upgradation. Shri O.P. Saharan has since been retired on superannuation on 30.04.2016 (as Assistant Commissioner).

3. On the said notional promotion, the pay of Shri O.P Saharan may be fixed in terms of provisions/instructions issued by the Board and DoP&T, New Delhi from time to time. However, the actual arrears of pay, if any, shall be paid from the date of judgement i.e. 05.09.2011 of the Hon'ble CAT, Jodhpur Bench, Jodhpur.

4. The above notional promotion will, however also, be subject to any judicial review as may be sought by the Department to contest the order or any other related pending judicial matter on the subject.
