Consequent upon the recommendations of the Regular DPC meeting held on 29.12.2022 for the panel / vacancy year 2023 for promotion to the grade of Tax Assistant, Group "C", following **Lower Division Clerks**, are hereby promoted to the grade of Tax Assistant, Group "C" in the Pay Band/Scale of Rs. 5200-20200 (PB-1) with corresponding grade pay of Rs. 2400 (Revised as Level-4 of Pay Matrix Rs. 25,500/- to Rs. 81,100/-) plus other allowances, as admissible, on regular basis, with effect from the date of assumption of the charge of the promoted post in pursuance of this order :

2. Consequent upon the said promotion, the above mentioned officers, if they are already **not** drawing the pay Level-4 of Pay Matrix Rs. 25,500/- to Rs. 81,100/- and above, under the MACP Scheme, may exercise option for fixation of their pay under FR-22(1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The promotion of the said officers, is subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

4. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.

5. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured in above list, is under suspension or facing any charge

sheet or prosecution, he should not be allowed to assume charge of the post of Tax Assistant, Group 'C' and this fact should be reported to this office immediately. In case, the officers are clear from the vigilance angle, their joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.
