**ESTABLISHMENT/CCU ORDER NO. 43/2022
DATED : 30.12.2022**

1. The Government of India, Ministry of Finance, Department of Revenue, Central Board of Indirect Taxes and Customs, New Delhi vide letter F.No. A-12018/01/2012.Ad.III.B dated 29.12.2022 in continuation of its earlier letter dated 23.12.2022 granting One Time Relaxation in the Recruitment Rules for the post of Executive Assistant, has stated that the approval of Competent Authority has been accorded to consider those **Tax Assistants who were in position as on the date of notification of Recruitment Rules of Executive Assistant in 2015 i.e. 28.09.2015 and who have completed more than 6 years of regular service as on 01.01.2022**, for filling up vacancies of Executive Assistant during the vacancy year 2022, as approved by DoP&T and UPSC.

The Board vide aforesaid letter dated 29.12.2022 has further stated to implement the **one-time relaxation in qualifying service** for promotion from Tax Assistant to Executive Assistant as per above relaxation in qualifying service in the existing Recruitment Rules of Executive Assistant notified vide G.S.R. 741 (E) dated 28.09.2015 and amended vide G.S.R. 135(E) dated 17.02.2017 and G.S.R. 657 (E) dated 26.08.2022, as applicable.

2. As per the specific directions of the Board vide aforesaid letter dated 29.12.2022, only those 23 officers who were working as Tax Assistant as on 28.09.2015 (i.e. date of notification of Recruitment Rules of Executive Assistant, Group 'B', Non - Gazetted, 2015 in the Gazette of India) and have completed more than 6 years of regular service as on 01.01.2022, have been considered for promotion to the grade of Executive Assistant, Group 'B' (Non-Gazetted) for filling up the vacancies for the vacancy year 2022, as approved by the DoPT and UPSC, by the DPC held on 30.12.2022.

3. As per the recommendation of the aforesaid DPC meeting held on 30.12.2022, the following Tax Assistants Group 'C' in the pay scale/band of Rs. 5200-20200 with grade pay of Rs. 2400/- in PB-1 (Revised as Level-4 in the pay matrix of Rs. 25500-81100) are hereby promoted to the grade of Executive Assistant, Group 'B' (Non Gazetted) on regular basis in the pay scale of Rs. 9300-34800 (PB-2) with grade pay of Rs. 4200/- (Revised as Level-6 in Pay Matrix Rs. 35400-112400) with effect from the date of assumption of charge of the promoted post i.e. Executive Assistant, Group 'B' (Non-Gazetted), in pursuance of this order :

Consequent upon the said promotion, the above mentioned officers, may exercise option for fixation of their pay under FR-22 (1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

5. The promotion of the said officers are subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

6. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.

7. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured in above list, is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Executive Assistant, Group 'B' (Non-Gazetted) and this fact should be reported to his office immediately. In case, the officers are clear from the vigilance angle, their joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.

This issues with the approval of the competent authority.
