3. The aforesaid promotion of the officer is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

4. The aforesaid promotion is also subject to the final outcome of the review DPC, if held for promotion to the grade of Inspector with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others before the Hon'ble CAT, Jaipur Bench, Jaipur.

5. The promotion of the said officer is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

6. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.
