Consequent upon the recommendations of the Supplementary DPC Meeting held on 28.12.2020 for promotion to the grade of **Head Havaldar, Group "C", Shri Dunger Singh (DOB - 04.01.1994)**, Havaldar, GST & Central Excise Commissionerate, Jodhpur (UOP to Customs, Jodhpur) is hereby promoted to the grade of Head Havaldar, Group "C" in Level-2 of Pay Matrix Rs. 19,900/- - Rs. 63,200/- plus other allowances, as admissible, on regular basis, with effect from his date of joining in pursuance of this order.

2. Consequent upon the said promotion to the grade of Head Havaldar, "Group C", **Shri Dungal Singh** is allocated to the Customs (Prev.) Commissionerate, Jodhpur, Hqrs., at Jaipur. Further specific posting of Shri Dungal Singh, on promotion post, will be decided by the Commissioner of Customs, Customs (Prev.) Commissionerate, Jodhpur, Hqrs. at Jaipur.

3. Consequent upon the said promotion, the above mentioned officer, if he is already not drawing the pay scale in Level-2 of Pay Matrix Rs. 19,900/- - Rs. 63,200/- and above, under the MACP Scheme, may exercise option for fixation of his pay under FR-22(1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1), dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. The promotion of the said officer is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

5. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion / seniority.


