2.1 That, in compliance of CBIC, New Delhi's Circular F.No. A-22015/117/2016-Ad.III A dated 20.09.2018, 73 Inspectors (including the said 3 Inspectors) who had been allowed ICT to Jaipur Zone after 26.12.2016, were treated as working on deemed loan basis in Jaipur Zone till 31.03.2019, vide this office Establishment Order No. 93/2018 dated 03.10.2018.

2.2 Being aggrieved, out of the said 73 ICT Inspectors, 71 Inspectors (including S/Shri Akhilshwar Mathur & Manish Kumar Chaudhary) had approached Hon'ble CAT Jaipur Bench, Jaipur by way of filing OAs. The Hon'ble Tribunal vide Orders dated 07.01.2019 had disposed of the said OAs as having been rendered infructuous in view of the order dated 15.11.2018 of the Hon'ble CAT, Bangalore Bench in OA No. 170/00101/2018. Subsequently, the department filed 8 Writ Petitions in the Hon'ble Rajasthan High Court at Jaipur against the said orders dated 07.01.2019 of Hon'ble CAT Jaipur Bench.

3. That, the aforesaid 3 Inspectors namely S/Shri Narendra Singh Shekhawat, Akhilshwar Mathur and Manish Kumar Chaudhary, have submitted their requests dated 02.03.2022, 08.07.2022 and 15.07.2022 respectively through proper channel for repatriation to their parent zone. The same have been considered and accepted by the Competent Authority. Hence, the said 3 Inspectors are hereby allowed for repatriation to their parent zone (i.e CGST & Central Excise Vadodara Zone) on their request. Accordingly, their controlling officers are requested to relieve the aforesaid Inspectors by 02.09.2022 positively, to join their parent zone, under intimation to this office.
