4. The promotion of Shri Umesh Sharma, who is on deputation shall be effective from the date he returns to the cadre and assumes charge of the promotional post in Jaipur Zone. His posting will be decided after joining in Jaipur Zone.

5. On promotion, benefit of option for fixation of pay in the promotional post shall be available to the officers named above in terms of provisions contained in the DoPT's O.M. No. DOPT-1667551701810 dated 13.09.2022, if admissible. They may exercise the option, if benefit of the same is admissible, within one month from the date of their promotion. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

6. The promotion of the officer mentioned in Para-2 above, to the grade of Superintendent, Group 'B' (Gazetted) is purely on adhoc basis. It does not confer any right for any claim for continued officiation or regular promotion or any other service benefit in the grade of Superintendent, Group 'B' (Gazetted). The period of such service will not count for seniority or as qualifying service for further promotion. The government reserves the right to terminate the adhoc promotion and revert him to the post from which he has been promoted.


7. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the Jarnail Singh batch of cases in the matter of reservation in promotion.

8. The promotion of the said officers is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

9. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letters F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 & F.No. A.32022/42/2016-Ad.IIIA dated 13.05.2024 and Order dated 26.09.2022 of Hon'ble CAT, Jaipur Bench, Jaipur in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others.

10. The promotion of the said officers is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.
