ESTABLISHMENT ORDER NO. 92 / 2021

Ms. Shivani Bhati, Stenographer Grade-II, Central GST & Customs, Pune Zone is hereby transferred to the CGST & Central Excise, Jaipur Zone on "**Loan Basis**" for a period of **two years**, on the following terms and conditions:

- (A) While working in the CGST & Central Excise, Jaipur Zone, all kinds of payments to Ms. Shivani Bhati, Stenographer Grade-II, towards her pay and allowances will have to be borne by her parent Zone. Her services will also be borne by her parent Zone i.e. she will be on the working strength of her parent Zone. She will not be entitled to any kind of special pay, allowance, etc.
 - (B) No transfer T.A. and joining time will be admissible to her in this event of transfer on "Loan Basis", since this transfer is being allowed on her own request.
 - (C) On this transfer on "Loan Basis", she will not be entitled for promotion, confirmation, seniority, etc. in CGST & Central Excise, Jaipur Zone.
 - (D) She will be liable to be transferred anywhere within the jurisdiction of CGST & Central Excise Commissionerate, Jaipur, Alwar, Jodhpur, Udaipur, Audit Jaipur, Audit Jodhpur, Appeals Jaipur, Appeals Jodhpur & Customs (Prev.) Commissionerate, Jodhpur (Hqrs. at Jaipur).
 - (E) She is liable to be repatriated to her parent Zone **at any time** without assigning any reason.
2. On having accepted the above terms and conditions and **if she is clear from the vigilance angle**, she may be relieved by her parent Zone with the directions to report to the undersigned not later than **15.10.2021**, failing which this order will liable to be cancelled without any further intimation.
