ESTABLISHMENT ORDER NO. 12 / 2021

Shri Ravi Prakash Chanda, Stenographer Grade-II, CGST, Central Excise & Customs, Nagpur Zone is hereby transferred to the CGST & Central Excise, Jaipur Zone on "Loan Basis" for a period of 2 years, on the following terms and conditions:

- (A) While working in the CGST & Central Excise, Jaipur Zone, all kinds of payments to Shri Ravi Prakash Chanda, Stenographer Grade-II, towards his pay and allowances will have to be borne by his parent Zone. His services will also be borne by his parent Zone, i.e. he will be on the working strength of his parent Zone. He will not be entitled to any kind of special pay, allowance, etc.
 - (B) No transfer T.A. and joining time will be admissible to him in this event of transfer on "Loan Basis", since this transfer is being allowed on his own request.
 - (C) On this transfer on "Loan Basis", he will not be entitled for promotion, confirmation, seniority, etc. in CGST & Central Excise, Jaipur Zone.
 - (D) He will be liable to be transferred anywhere within the jurisdiction of CGST & Central Excise Commissionerate, Jaipur, Alwar, Jodhpur, Udaipur, Audit Jaipur, Audit Jodhpur, Appeals Jaipur, Appeals Jodhpur & Customs(Prev.) Commissionerate, Jodhpur(Hqrs. at Jaipur).
 - (E) He may be repatriated to his parent Zone even before completion of 2 years period in the event of joining of new/regular candidate in Jaipur Zone in the same grade/post. Further, he is also liable to be returned back at any time to his parent Zone without assigning any reason.
2. On having accepted the above terms and conditions and if he is clear from the vigilance angle, he may be relieved with the directions to report to the undersigned not later than **22.02.2021**, failing which this order will liable to be cancelled without any further intimation.
 3. This issues with the approval of Chief Commissioner, CGST & Central Excise, Jaipur Zone, Jaipur.
