
2. The point wise reply of your RTI application is given below:-

The data of physically handicapped person working in Superintendent cadre in CBIC is maintained by concerned CCAs and Roaster in terms of para 10 of the notification no. 36012/1/2020-Estt (Res-II) dated 12.05.2022 is not available in Ad.IIB Section as the Cadre of Superintendent is a decentralised Cadre.

3. Therefore, your RTI Application is being transferred to all CCAs under Section 6(3) of RTI Act, 2005.
