ESTABLISHMENT ORDER NO. 55/ 2021

The following Tax Assistants of CGST & Central Excise and Customs are hereby transferred to CGST & Central Excise, Jaipur Zone on “**Loan basis**” for a period as shown against their names, on the following terms and conditions:

- (A) While working in the CGST & Central Excise, Jaipur Zone, all kinds of payments of all the said Tax Assistants, towards their pay and allowances will have to be borne by their respective parent Zone. Their services will also be borne by their parent Zone, i.e. they will be on the working strength of their parent Zone. They will not be entitled to any kind of special pay, allowance, etc.
- (B) No transfer T.A. and joining time will be admissible to them in this event of transfer on “Loan Basis”, since these transfers are being allowed on their own requests.
- (C) On this transfer on “Loan Basis”, they will not be entitled for promotion, confirmation, seniority, etc. in CGST & Central Excise, Jaipur Zone.
- (D) They will be liable to be transferred anywhere within the jurisdiction of CGST & Central Excise Commissionerate, Jaipur, Alwar, Jodhpur, Udaipur, Audit Jaipur, Audit Jodhpur, Appeals Jaipur, Appeals Jodhpur & Customs(Prev.) Commissionerate, Jodhpur(Hqrs. at Jaipur).
- (E) They are liable to be repatriated to their parent Zone at any time without assigning any reason.

2. On having accepted the above terms and conditions and if they are clear from the vigilance angles, they may be relieved by their respective zone with the directions to report to the undersigned not later than **29.07.2021**, failing which this order will liable to be cancelled, in respect of individual concerned, without any further intimation.
