Consequent upon the recommendations of the Review DPC Meeting held on 27-28.07.2020 in respect of DPC Meetings held on 25.06.1997 and 29.08.1997, for promotion to the grade of Superintendent, "Group B", in terms of the order dated 03.08.2012 of the Hon'ble CAT, Chandigarh Bench in O.A. No. 338/PB/2012 filed by Shri Balwinder Singh Matharoo & Others read with order dated 26.08.1997 of the Hon'ble CAT, Principal Bench, New Delhi in OA No. 651/97 filed by Shri I.C. Joshi & Others, order dated 05.09.2011 of the Hon'ble CAT, Jodhpur Bench, Jodhpur in OA No. 217/1998 filed by Shri Om Prakash Saharan and Boards direction / clarification issued vide letters F. No. C-18012/19/2012-Ad.IIB, dated 03.08.2017 and 31.12.2019, following the then Inspectors are hereby promoted to the grade of Superintendent, Group 'B' on notional basis w.e.f. the date mentioned against their names on the basis of length of service rendered by them in the grade of Inspector (i.e. from the date of their initial appointment to the post of Inspector) in Customs and Central Excise Department. On notional promotion, the inter-se-seniority of these officers has been fixed in the grade of Superintendent, Group 'B' as per S.No. 1 to 5 assigned to them respectively, in the following list: -



2. On said notional promotion, their seniority will remain at the bottom of the order issued in respect of other officers who got promotion in the respective phase of upgradation as per the extent of rules, since, their service only be counted for the purpose of eligibility in the upgradation. All the above officers have since been retired on superannuation / VRS in the year 2011 to 2019 except Shri N.R. Meena, who had expired on 30.10.1999.

3. On said notional promotion, their pay may be fixed in terms of provisions / instructions issued by the Board and DoP&T, New Delhi from time to time. However, to avoid anomaly at zonal level, the actual arrears of pay, if any, shall be paid from the date of

4. The above notional promotion will, however also, be subject to any judicial review as may be sought by the Department to contest the order or any other related pending judicial matter on the subject.
