3. Since the transfer of officer mentioned at Sr. No. 3 of above table, has been made on his own request, he shall not be entitled for any TTA or Joining Time.


4. All the officers mentioned above must be relieved immediately and they must join at their new place of posting, on or before 24.08.2021, under intimation to the undersigned. The


