Subject :- **Implementation of Hon'ble Mumbai High Court Judgment
Writ Petition No. 298 of 2013.**

Sir,

I am directed to refer to your office letter C.No.II-26(25)CCU/JZ/2015/1918 dated 07.01.2016 on the above mentioned subject and to state that the matter has been examined by the Board.

- It is informed you that the Board had examined the similar case of Mumbai Central Excise in consultation with the Law Ministry by taking into all facts, legal position, the Board has taken conscious decision and same was clarified to Central Excise, Mumbai that 449 posts of Inspectors which have been upgraded to the post of Superintendents are no longer available in the grade of Inspector prior to restructuring. Hence, filling up these 449 vacancies of Inspector on the basis of Recruitment Rules, 1979 of Inspectors is not in order. These instructions superseded all earlier instructions.
- The aforesaid decision was communicated in pursuance of Hon'ble Mumbai High Court judgment passed in Writ Petition No. 298 of 2013 read with Original Application No. 510 of 2010 passed by Hon'ble Central Administrative Tribunal, Mumbai Bench. These judgments having all India ramification and need to be implemented by all Cadre Controlling Authorities to the grade of Inspectors.
- Since 118 posts of Inspectors which have been upgraded to the grade of Superintendents are no longer available in the grade of Inspector prior to Cadre Restructuring. You are therefore requested to review all the DPCs conducted for the period from 06.12.2002 keeping in view of non-availability of upgraded posts of Inspectors.
- This issues with the approval of Member (A), CBEC.
