Shri Jaivardhan Dayama, Inspector, Central Tax & Central Excise, Hyderabad Zone, is transferred to the CGST & Central Excise, Jaipur Zone on "Loan Basis" for a period of 1 year, in terms of instructions contained in the Circular F.No. A-22015/117/2016-Ad. IIIA dated 20.09.2018 of the Central Board of Indirect Taxes and Customs, New Delhi, on the following terms and conditions:

- (A) While working in the CGST & Central Excise, Jaipur Zone, all kinds of payments to Shri Jaivardhan Dayama, Inspector towards his pay and allowances will have to be borne by his parent Zone. His services will also be borne by his parent Zone, i.e. he will be on the working strength of his parent Zone. He will not be entitled to any kind of special pay, allowance, etc.
- (B) No transfer T.A. and joining time will be admissible to him in this event of transfer on "Loan Basis", since this transfer is being allowed on his own request.
- (C) On this transfer on "Loan Basis", he will not be entitled for promotion, confirmation, seniority, etc. in CGST & Central Excise, Jaipur Zone.
- (D) He will be liable to be transferred anywhere within the jurisdiction of CGST & Central Excise Commissionerate, Jaipur, Alwar, Jodhpur, Udaipur, Audit Jaipur, Audit Jodhpur, Appeals Jaipur, Appeals Jodhpur & Customs(Prev.) Commissionerate, Jodhpur(Hqrs. at Jaipur).
- (E) He is liable to be returned back at any time to his parent Zone without assigning any reason.

2. On having accepted the above terms and conditions and if he is clear from the vigilance angle, he may be relieved with the direction to report to the undersigned not later than 20.07.2020, failing which this order will liable to be cancelled without any further intimation.

3. This issues with the approval of the Chief Commissioner, CGST & Central Excise, Jaipur Zone, Jaipur.
