Dear Madam/Sir,

1. Undersigned is 76 years old Army veteran & Citizen of India since birth. Photocopy of Aadhar card no.949164897682 is enclosed as Annexure 01. I am also Director (DIN00572195) of a company named as M/S Thar Hotels Pvt. Ltd. whose details are as per the photocopy of 'Company Master Data' of the company enclosed as Annexure 02. As of today my group holds above 74.83% of shares of this company.
2. In the first week of December 2023, I accidentally found on the net that one G.S.T. issued on 09/11/2020 in the name of Mr. Yogendra Singh Bhati & the 'Principal place of Business' mentioned here was HIMMATGARH PALACE, Ramgarh road, Jaisalmer. I was also surprised to find exactly the same venue mentioned as 'Principal place of work' on G.S.T. no.08AAACT6786B2Z7 DATED 01/07/2017 issued on the name of my company M/S Thar hotels Pvt. Ltd. This GST no. was valid & in vogue on 09/11/2020 when second GST NO. ((08AASPB5893J2ZQ) was issued. Thus creating this duplicacy/dichotomy by the GST department itself, for the reasons best known to them. Mr. Yogendra Singh Bhati is a trespasser & illegally managing hotel Himmatgarh Palace Jaisalmer without any permission. He has kept this information secret & never disclosed to anyone. He is misusing this GST no. till date. This has caused sever damage to our company's business, market position & branding plus he is syphoning of total revenue from our only business unit of our company for past nearly four years.
3. Incidentally the hotel Himmatgarh Palace & its land on which it is built belongs to our company M/S Thar Hotels Pvt. Ltd. So far it has never been rented or leased out to anyone. Our company is the SOLE PROPERITOR of this property. If anyone else is claiming its proprietorship then it's totally false, fraudulent & fictitious attempt of cheating.

4. In view of the above my humble prayer to GST office Jaisalmer is to share with me the information about the Documents/Evidence showing ownership of hotel Himmatgarh Palace Jaisalmer by Mr. Yogendra Singh Bhati, before issuing second GST No. for the same venue/Property. The certified true copies of documents may please be provided at the earliest possible.

5. Prior to choosing this RTI route, since 28th December 2023 (now 48 days), I had requested Asst. Comm. State GST Jaisalmer for help pertaining to this subject matter by writing speed post letters, reminders, e-mails, telephone calls etc. without any response!! Similarly, letter to CGST Commissionerate Jodhpur dated 19/01/2024 has also not yielded any response till date. Thus lot of valuable time has already been unnecessarily wasted.

6. Thus the information sought by me concerns the life or liberty of a person, hence as per law it should be supplied to me within 48 hours. However as per normal course period of 30 days is allowed but concerned department has already wasted my 48 days!! Therefore, it is requested that desired information may please be supplied to me within ten days from the date of this letter. Any further delay will be harmful & injustice to me.


