2. All representations/requests for transfer received post AGT have been disposed of, after due consideration and no further representations will be entertained.
3. All the above officers must be relieved immediately and should join their new place of posting on or before 24.06.2019.
4. While issuing Orders for specific charge/postings, the Transfer Policy guidelines 2018 and the History of Posting (HoP) of the officers should be kept in mind, so as to ensure proper rotation – sensitive & non-sensitive norms etc. as prescribed by the instructions issued by CVC/ CVO. In case of any deviation from the Transfer /Placement Guidelines, prior approval of the Chief Commissioner should be taken by the respective Principal Commissioners/Commissioners.
5. The officers mentioned at S.No. 1, 3, 4, 5, 7 & 15 shall not be entitled for TTA & Joining Time as their request for transfer/retention has been acceded to.
6. The Principal Commissioners/Commissioners should ensure that before relieving the officers, they hand over their charge under proper Handing Over /Taking Over note. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to officer taking over the charge by the officer handing over the charge. The officers should also make a not for the successor on issues of current importance, urgency of actionable point, critical issues as envisaged in DOP&T OM No. 13024/01/2014-(Trg-Ref) dated 26.09.2014.
