With reference to the information sought the pointwise reply is as under:-

Point No.1: *The information sought is not covered under definition of information under Section 2(f) of the RTI Act, 2005.*

Point No.2: *2 Tax Assistants have joined on Inter Commissionerate Transfer basis in CGST & Central Excise, Jaipur Zone after, November-2021.*

Point No.3: *The Inter Commissionerate Transfers are made against vacancies in direct recruitment quota. There is no separate quota for Inter Commissionerate Transfer. In the new Recruitment Rules of Tax Assistant issued vide G.S.R 785(E) dated 20.10.2022 there is no provision for Inter Commissionerate Transfer in the grade of Tax Assistant. Clear vacancies in the direct recruitment quota in the grade of Tax Assistant as on 31.12.2021, against which ICT application could have been considered in the grade of Tax Assistant is 2."*
