2. Time Schedule:

- i. The Goods can be inspected between 11.00 AM to 5.00 P.M. on 09/10 Oct., 2020, at M/s Aakash Agencies, Godown at Plot No. 303, Rajendra Nagar, Scheme No. 4, Near Adarsh school, Alwar
- ii. Closing date & time for receipt of Bid: up to 14:00 Hrs. on 12th Oct., 2020.
- iii. Place for submitting bid: Shri G.P. Gupta, Superintendent, Room No. 2.12, Central Goods & Services Tax Commissionerate, Alwar. The cover of the bid documents should be prominently super-scribed with words "QUOTATION FOR PURCHASE OF SEIZED GOODS".
- iv. Bid Opening date, Time and venue: Same day, soon after the closing time of bidding at Central Goods & Services Tax Commissionerate, Alwar.

3. Terms and conditions:

- i. GSTIN Holder is only eligible to participate in the bidding process.
- ii. Bid security of Rs. 50,000/- may be in the form of Demand Draft/Pay order drawn in favour of "**Administrative Officer, Central Goods & Services Tax Commissionerate, Alwar**" must be enclosed with the bid. Bids without bid Security or in any other form i.e. cheque or cash etc. will not be considered.
- iii. The successful bidder will be required to deposit the bid amount by means of DD drawn in favour of **Administrative Officer (D.D.O.), Central Goods & Service Tax Commissionerate, Alwar within 5 working days from the date of the acceptance of the bid by the Department.**
- iv. **If it is found that the amount quoted by the successful bidder (i.e. highest bidder) is less than the reserve price fixed by the valuation committee or the total number of bidders are less than two, the bid will be treated as cancelled.**
- v. The Earnest Money of the successful bidder will be released only after the deposit of sale proceeds. Earnest Money will be forfeited if he fails to honour the bid.
- vi. The successful bidder have to remove the Goods at his own cost on the same day of final payment, failing which resale of the Goods will be undertaken at the risk and cost of the defaulter.
- vii. The Goods will be disposed off on "as is where basis is" and no guarantee for its worthiness or quality will be given by this Department.

- viii. The Department will not be responsible for any lapse on his part in this regard.
- ix. The bidders will not be allowed to withdraw their bids, failing which their Earnest Money will be forfeited.
- x. The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
- xi. All taxes/levies as applicable will be borne by the buyer over and above the bid price.
- xii. Staff and officers of Central Board of GST & Customs are not eligible to participate in the bidding process.
