Consequent upon the recommendations of the DPC meeting held on 28.12.2022 for regular promotion to the grade of Driver Grade-I, Group 'C', Non Gazetted (Non-Ministerial) for the Vacancy Year 2023, **Shri Dharm Singh Meena (ST)**, Driver Grade-II (DOB – 01.08.1977), CGST & Central Excise Alwar is hereby promoted to the grade of Driver Grade-I, Group 'C', Non Gazetted (Non-Ministerial) on regular basis in the pay scale/band of Rs. 5200-20200 (PB-1) with grade pay of Rs. 2800/- (revised as Level-5 in Pay Matrix of Rs. 29200-92300) with effect from the date of assumption of charge of promoted post in pursuance of this order.

2. Consequent upon the said promotion, the above mentioned officer, if he is already **not** drawing the pay scale of Rs. 5200-20200 (PB-1) with grade pay of Rs. 2800/- (revised as Level-5 in Pay Matrix of Rs. 29200-92300) and above, under the MACP Scheme, may exercise option for fixation of his pay under FR-22 (1) (a) (1) within one month from the date of his promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The promotion of the said officer is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

4. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.

5. The Principal Commissioner, CGST Alwar and supervisory authority concerned shall ensure that if the aforesaid officer, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Driver Grade-I and this fact should be reported to this office immediately. In case, he is clear from the vigilance angle, his joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.
