Consequent upon the said promotion, the above mentioned officers, if they are already **not** drawing the pay Level-4 of Pay Matrix Rs. 25,500/- to Rs. 81,100/- and above, under the MACP Scheme, may exercise option for fixation of their pay under FR-22(1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

3. The promotion of the said officers, is subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

4. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.
