3. The officers mentioned at Sl. No. 57 to 104 have been transferred on their own requests or have been repatriated w.r.t. earlier AGTs, therefore, they shall not be entitled for any TTA or Joining Time.

4. It is further requested that Orders indicating specific charge/ postings within the Commissionerates, should be issued by the respective Pr. Commissioner/ Commissioners by **12.06.2024** positively. While issuing orders for specific charge/ postings, the Transfer Policy Guidelines, 2018 (as amended), History of Postings of the officers and various instructions w.r.t. sensitive and non-sensitive postings issued by CVC/ CVO time to time, should be kept in mind.

5. In case of any deviation from the existing Transfer Policy, prior approval of the Chief Commissioner is required to be obtained.

6. The Pr. Commissioner/ Commissioners must ensure that all the transferred officers be relieved by **14.06.2024**. A Compliance report regarding relieving/ joining of the officers, should reach this office by **19.06.2024** from all the Commissionerates.

7. The Pr. Commissioners/ Commissioners should ensure the proper Handing Over/ Taking Over of charges at the time of relieving / joining in respect of officers under their charge. This should include exchange of a list of pending tasks for the job.
