3. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

4. The aforesaid promotion of officers is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

5. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letter F.
