9. The Pr. Commissioners/ Commissioners should ensure the proper Handing Over/ Taking Over of charges at the time of relieving / joining in respect of officers under their charge.

10. All the representations received regarding transfer and posting / retention in the grade of Superintendent are hereby stands disposed off. No further representation shall be entertained before the officers join at their new place of posting.
